(IB) No. 764/(ND)/2022) and the said appeals were thereafter dismissed by the Hon'ble NCLAT.

That the Resolution Plan Approval Order of United News of India was upheld by the Hon'ble NCLAT on 1st May 2025.

That regarding the NCLAT order dated 1 May 2025, the erstwhile Resolution Professional/ Monitoring Agent had duly filed the INC28 with the MCA on 2nd May 2025 and the NCLAT Order was also uploaded on the website of the Corporate Debtor.
